#### **BACKGROUND**

Transparency International (TI) is the global civil society organisation leading the fight against corruption. In collaboration with nearly 100 chapters worldwide and an international secretariat in Berlin, Germany, TI raises awareness of the damaging effects of corruption and works with partners in government, business and civil society to develop and implement effective measures to tackle it.

The "Transparency Now: Strengthening Anti-Corruption Efforts in the EU Southern Neighbourhood" project is funded by the European Commission and implemented jointly with the United Nations Interregional Crime and Justice Research Institute (UNICRI). It aims at strengthening the prevention, reporting, investigation and prosecution of acts of cross-border corruption, facilitating the seizure and confiscation of assets and supporting the establishment of effective asset recovery mechanisms in the EU Southern Neighbourhood countries.

TI-Secretariat is looking for a consultant to support a training on reporting anti-corruption, targeting a group of investigative journalists from the Middle East and North Africa (MENA) Region.

## **OBJECTIVES**

The Transparency International Secretariat (TI-S) is currently seeking to contract an Arabic-speaking **Anti-Corruption Investigative Journalism Consultant** to support a training course targeting investigative journalists throughout EU Southern Neighbourhood. The trainings' goal is to empower journalists with the necessary skills to professionally uncover and report on possible acts of national and cross-border corruption, as well as for reporting aimed at improving government and private sector transparency, in support of TI-S's strategic priority of combatting corrupt money flows. More specifically the project is focused on advancing this agenda in the European Union's (EU) Southern Neighbourhood, specifically in Morocco, Algeria, Tunisia, Libya, Egypt, Lebanon, Palestine, Jordan.

As part of this agenda, the **Anti-Corruption Investigative Journalism Consultant** will be responsible for drafting a training module in line with this objective, providing a 3-day in-person training and performing the necessary follow-up after the training.

The consultancy is currently estimated to start in April 2025 and continue for approximately 2 months.

### **EXPECTED DELIVERABLES AND TIMELINE**

All presentations and reports should be submitted in either English or Arabic as agreed on with project team, in electronic form, in accordance with the deadlines stipulated above. The Consultant is responsible for editing and quality control of language. The TI Secretariat retains the sole rights with respect to all distribution, dissemination, and publication of the deliverables.

### **SELECTION CRITERIA**

The Consultant should have the following qualifications:

- Extensive knowledge and expertise of reporting on anti-corruption required, with demonstrated investigative journalism experience in anti-money laundering and illicit financial flows.
- Preferably Master of Investigative Journalism equivalent experience in the field and a university degree with a journalism focus might also be considered.
- A proven track record in delivering training sessions or workshops related to Illicit Financial Flows
- Professional knowledge of Arabic and English languages, both speaking and writing, are essential for this consultancy.
- Regional Work Experience: Preference will be given to candidates with experience working in the EU Southern Neighbourhood. Applicants should highlight their familiarity with local contexts, challenges, and opportunities based on their work experience, in their cover letters.
- Applicants are encouraged to include information about their involvement in relevant media and/or professional networks within the region, including but not limited to, roles, memberships, or partnerships with organizations, groups, or other bodies related to the subject of the training.
- Solid writing, editing and communication skills.
- Ability to work in a team as well as independently, particularly in distance communication.

- Strong interpersonal, teamwork and intercultural communication skills, particularly at distance communication.
- Commitment to the values and principles of Transparency International.

  - Technical part to include a proposed agenda for a three-day training with a short text explaining the logic behind the selection of each agenda item and its order in the overall training plan.
  - Financial part to include an outline of the days needed for each of the deliverables, in addition to their daily rate and full fee in euro.
- Applicants must provide information about recent two training workshops they conducted, including the topics covered, the duration, and the target audience.

All travel booked by TI-S will include **travel health and accident insurance** with worldwide coverage and Economy class only; accommodation will aim to achieve best value for money up to a 4-star category.

Consultants shall be entitled to invoice TI-S **only** for local transportation and visa cost (if applicable).
