### BACKGROUND

Transparency International (TI) is the global civil society organisation leading the fight against corruption. Through more than 100 chapters worldwide and an international secretariat in Berlin, Germany, TI raises awareness of the damaging effects of corruption and works with partners in government, business and civil society to develop and implement effective measures to tackle it.

The Transparency International Secretariat (TI-S) in Berlin is seeking experienced freelance professionals (suppliers) to create, design, draft and finalise media content for print and online publications.

### OBJECTIVES, DELIVERABLES & TIMELINES

Suppliers will work on individual projects on an ad-hoc basis, with specific deliverables to be defined on a case-by-case basis according to the profile of the supplier. They are asked to combine art, design and creative skills to develop ideas and produce original visual images within Transparency International's identity guidelines for a wide range of products. These may include:

- reports and book covers
- educational, training and reference material
- instruction manuals, leaflets and brochures
- greetings cards, giftware and packaging
- advertising material and posters
- magazines and newspapers
- websites and social media visuals

TI-S will retain sole intellectual property rights with respect to all distribution, dissemination and publication of the deliverables.

### SELECTION CRITERIA

Candidates should have the following experience/qualifications:

- At least 4 years of professional experience as an illustrator
- A degree in illustration, visual art, graphic design or visual communication or equivalent work experience (at least 5 years)
- Excellent oral and written communication skills in English
- Experience of working to strict deadlines, with the ability to react quickly to short project turnaround times
- Excellent drawing, sketching, painting and photographic skills, digital and analogue
- Experience with colour correction, colour matching and management

## REMUNERATION AND COSTS

Candidates are expected to provide Standard Rates per hour in Euro, as **gross inclusive of taxes and other charges**.

Candidates who are based in Germany and do not charge German VAT must confirm their small entrepreneur status.

- Concept/design
- Layout/inking/colouring
- Corrections/preparing for print/etc.

Please note that remuneration will be limited to these standard rates included in the proposals. No additional payment will be given for other costs incurred (for example, travel, accommodation, materials).
