Title of Consultancy: Research on the intersection between land corruption and the

climate crisis

BACKGROUND

Transparency International (TI) is the global civil society organisation leading the fight against corruption. Through more than 100 chapters worldwide and an international secretariat in Berlin, Germany, TI raises awareness of the damaging effects of corruption and works with partners in government, business, and civil society to develop and implement effective measures to tackle it.

The Transparency International Climate Governance Integrity Programme (CGIP) intervenes to reinforce accountability from local to global level, and throughout the whole chain: from policy development to project implementation and monitoring. The Land and Corruption in Africa (LCA) programme seeks to address corruption in land management and administration in sub-Saharan Africa through research, advocacy, and awareness raising at the local, national, regional, and global levels. This consultancy is a joint venture between these two programmes at the TI Secretariat (TI-S).

To deepen our understanding of the way in how climate and land corruption intersect, TI-S is looking for a consultant to develop a **short research paper** looking at both the impact of land corruption on carbon emissions, as well as the ways in which the response to the climate emergency may present risks for land corruption. The research will combine a literature review with expert interviews to identify key impacts and corruption risks and suggest tentative recommendations to mitigate these risks, including the need for further research. This research would be a first step towards framing the issue and would be complemented by further research into some of the primary areas of corruption risk identified which would take place later in the year.

OBJECTIVES

Research objectives:

The main goal of the research is two pronged. The first aspect of the research should look at how land corruption may be negatively impacting climate efforts, including its impact on mitigation and adaptation strategies. The second aspect of the research should look at how climate change response may contribute to land corruption.

To this effect, the research is expected to:

- Identify the major impacts of land corruption on the climate effort and provide an overview of these impacts with two illustrative case studies
- Identify land corruption risks that are present in the climate response and provide a general overview of these risks with two case studies documenting how they may be vulnerable to corruption. Recommended areas to explore include green grabbing, land and mineral requirements in the green energy transition, land corruption risks, carbon offsetting and initiatives, and land use changes. Other areas of focus may emerge in the course of the research.
- Make recommendations for national governments, civil society, and donors and multilateral agencies on how to address the impact and risk of land corruption in this area and document three best practices.

Research Methodology:

The research should be partly desk-based, with a literature review of existing data sources, and partly empirical, with a series of semi-structured interviews with experts. The consultant and TI-S will work together to identify a list of relevant experts, which will include experts from the fields of land governance, anticorruption, and environment/climate work. TI-S and the consultant will also work to identify the four case studies that illustrate both aspects (impact and risk) by working with partners and with TI national chapters.

Based on these interviews and the review, the consultant will put forward a proposed outline for the research paper as well as the proposed case studies to include in the report. The report will be drafted over May with feedback from TI's land and climate teams and potentially partners in the land governance community. In accordance with TI policy, all research should clearly indicate and acknowledge all sources used and the reader should be able to trace the source of information in footnotes and bibliography.

The timeline is envisioned as follows:

- Step 1: Scoping exercise/literature review & interview guide development (Weeks 1, 2, 3)
- Step 2: Interviews with experts, partners and with representatives of chapters to identify potential case studies (Week 3, 4, 5)
- Step 3: Proposed document outline and case studies (Week 5)
- Step 4: Development of first draft (Week 6, 7)
- Step 5: Development of final draft based on feedback (Week 8, 9)

EXPECTED DELIVERABLES AND TIMELINE

The expected deliverables are set out below:

- Proposed structure for the report (deadline May 14)
- First draft of the report about 6-8 pages in a style appropriate for the audience of policy makers, civil society practitioners, and the donor community (deadline May 21)
- A final report within two weeks after receiving and incorporating feedback on draft report. The
 report should follow Tl's style guidelines which will be provided at the start of the consultancy
 (deadline June 15)

Please note that this timeline is tentative and can be revised once a research consultant has been selected and a research plan has been drawn up.

Suggested report structure:

- 1. Background/introduction
- 2. Impact of land corruption on the environment and on people including 2-3 case studies. The following areas should be covered:
 - a. Impact on greenhouse gas emissions and environmental damage
 - b. Impact on adaptation solutions
 - c. Tenure security & displacement with reference to impact on marginalised groups including land and environmental defenders and whistle-blowers.

Land corruption risks in the climate change response and environmental and green initiatives including 2-3 case studies. The following areas should be covered:

- d. Introduction to green grabbing
- e. Carbon offsetting and carbon credit initiatives
- f. The demand for land and minerals in the green energy transition
- g. Land use changes and green grabbing
- 3. Recommendations for national governments, civil society, and donors and multilateral agencies on mitigating land corruption risks in the climate change response and environmental protection initiatives including further research needs. This section should include some identified good practice in tackling land corruption in the climate response and environmental initiatives, with examples. For examples, social accountability tools, investigative journalist, etc.

All presentations and reports are to be submitted in English, in electronic form, in accordance with the deadlines stipulated above. The Consultant is responsible for editing and quality control of language. TI-S retains the sole rights with respect to all distribution, dissemination and publication of the deliverables.

SELECTION CRITERIA

The Consultant should have the following qualifications:

- Expertise in the fields of land governance and/or climate governance with significant proven experience producing research reports and recommendations on the topic
- Demonstrated experience with both qualitative and quantitative research methods
- Wide experience of working with clients in civil society and particularly advocacy-oriented NGOs
- Excellent writing and presentation skills in English
- Ability to operate under strict time limits and apply high production and technical standards for the purpose of maintaining a high level of professionalism.

REMUNERATION AND COSTS

The consultant should provide their estimated total fee as a lump sum or as standard daily or hourly rates as gross inclusive of taxes and other charges, as well as the number of estimated days to complete the consultancy.

- Curriculum vitae of the consultant.
- 2-3 samples of relevant research (confidentiality guaranteed).
- References from two previous consultancy clients whom TI could contact.
